The cherry blossoms season is approaching in Japan. Cherry blossoms start to bloom in the southern part of the Kyusyu area of Japan and then moves up to the North.

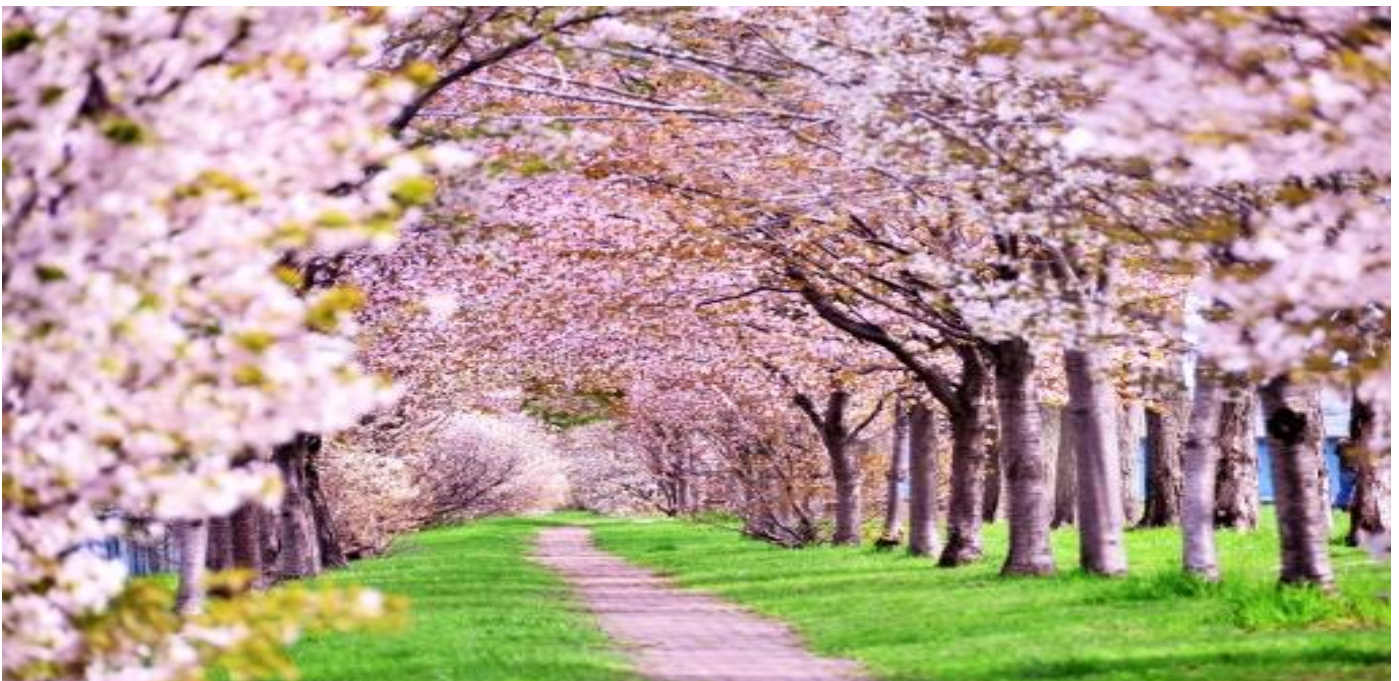
Fully bloom in the Tokyo area is expected to be 24MAR on this year.

## **// NEW IMMIGRATION RESTRICTION ///**

**New restriction was published in Japan due to coronavirus.**

**From 27th February 2020, the following people are not permitted to enter Japan for the time being unless there are exceptional circumstances.**

- Foreigners who have travelled to Hubei Province in the People's Republic of China within 14 days before arriving in Japan.**
- Foreigners who have Chinese passports issued by Hubei Province in the People's Republic of China.**
- Foreigners who have travelled to Daegu Metropolitan City or Cheongdo county in North Gyeongsang Province in Republic of Korea within 14 days prior to their arrival in Japan.**

### **OLYMPICS UPDATE**

**Please be aware that “special coordination” started from 01 DEC 2019 to 20 AUG 2020 for the TOKYO Olympics and Paralympics. The submission of Non-scheduled Flights for both Tokyo Metropolitan Airports (RJAA/NRT, RJTT/HND, and RJAH/IBR\*) and Specially Designated Airports (RJSS/SDJ, RJGG/NGO and RJCC/CTS) can be made during this period.**

**The Tokyo Olympics will be held from 24 JUL through 9 AUG in 2020 followed by the Paralympics, which will be held from 25 AUG through 6 SEP. During the Olympics and Paralympics, a “Special Coordination Office” will be set up at the JCAB Tokyo Airport Office and this office will solely control the slots for Non-Scheduled Flights (including a business jet flight that is not related to the Olympics) occurring from 01 JUL to 30 SEP for the airports below.**

**If you have a trip planned to use any of the above airports between 01 JUL and 30 SEP 2020, please send us your schedule by the deadline of each month for the application. (please see the application schedule below.\*\*)**

slots are still available. The applications received before the 20<sup>th</sup> of each month will be processed and notifications will be sent out by the end of the month. The restriction of each airport as below for these period.

Slot requests will be accepted only for Guest Category (please refer to the category below) during the “Peak Period” of:

**-21 to 25 JUL, 08 to 10 AUG, 22 to 26 AUG and 05 to 07 SEP.**

Slots for all Non-scheduled flights except the above peak periods can be applied for the allocation period of each month.

**/// RJAA /// RJAH /// RJCC /// RJGG /// RJSS ///**

All types of Non-scheduled Flights can be applied.

At RJTT, RJAA and RJAH aircraft can only remain parked for a maximum of 3 hours. After that, aircraft will be required to reposition to another airport of entry in Japan for parking. A repositioning airport will also be assigned by the Special Coordination Office. If you have request airport for parking, please also advise with your schedule.

### RJTT (Haneda)

**The most popular Tokyo-area airport, near downtown Tokyo  
Hard to get slots and parking spots**

**Operational Hours: 24hrs**

**CIQ Hours: 24hrs**

**Parking Restriction: 4nights/5days at a maximum**

**Business Aviation Terminal: Available (260,000JPY + TAX per ARR or DEP)**

**■Only passengers can use this facility. Crew need to clear CIQ in the main terminal**

### RJAA (Narita)

**Another airport in Tokyo-area (only 60-70 min to downtown Tokyo)**

### Advantages of using RJAA

- **Easier to get slots/parking spots (the number of available spots for GA aircraft: 16)**
- **Longer duration parking allowance (up to 30days)**
- **Hanger is available for parking**
- **Sufficient ground service availability including providing O<sub>2</sub> and N<sub>2</sub> etc...**

**Operational Hours: 0600L – 2259L (2100Z - 1359Z)**

**CIQ Hours: 0600L – 2300L (2100Z - 1400Z)**

**Parking Restriction: 29nights/30days at a maximum**

**Business Aviation Terminal: Available (250,000JPY + TAX per ARR or DEP)**

### **RJCC (New Chitose)**

**The gateway to the Northern part of Japan**

**Overnight parking is available from 01APR to 30NOV**

**Chinese, including Hong Kong and Macau based operators are NOT able to operate/park overnight at RJCC except during the following hours.**

**Mondays – Thursdays : Between 1200L and 1659L (0300Z and 0759Z)**

**Fridays : Between 1200L and 2159L (0300Z and 1259Z)**

**Saturdays : Between 0700L and 2159L(2200Z and 1259Z)**

**Sundays : Between 0700L and 2159L(2200Z and 1259Z)**

**\*The same restriction applies to operators based in and aircraft registered in the following countries: Russia, India, Vietnam, Iran, Iraq, Syria, Libya, Cuba, Ukraine, North Korea.**

**Quarantine: 24hrs, but advance notice is required**

**Parking Restriction: 6nights/7days at a maximum**

**Business Aviation Terminal: NOT Available**

### **RJBB (Kansai)**

**Good access to Osaka, Kyoto, and the Kobe Area**

**Operational Hours: 24hrs**

**CIQ Hours: 24hrs**

**Parking Restriction: None, but aircraft may not be able to stay at the same spot from arrival through departure if it parks for a long period. Aircraft may be required to move to an overnight parking spot. Towing service is not available**

**Business Aviation Jet Terminal: Available (200,000JPY + TAX per ARR or DEP)**

**■ Crew will be able to use this facility only if they clear CIQ at the same time as passengers do, otherwise the crew need to clear CIQ at the main terminal. In the main terminal, a Fast Lane is available at immigration for**

**ONLY ARRIVAL passengers. The service is not extended to customs. Also, Japanese passport holders cannot use this service.**

### **RJGG (Chubu Centrair)**

**Easy to get slots and parking spots, good service availability**

**Slot Application: Slots can be applied for anytime, but their availability will be released at the end of each month for the next month's operations.**

**Operational Hours: 24hrs**

**CIQ Hours: 24hrs**

**Parking Restriction: None, but aircraft may not be able to stay at the same spot from arrival through departure if it parks for a long period. Aircraft may be required to move to an overnight parking spot.**

**Business Aviation Terminal: Available (Free of charge), but advanced coordination with CIQ is required.**

### **RJNA (Nagoya Komaki)**

**A Nagoya-area airport closer to downtown than RJGG**

**Easy access to aircraft through a dedicated business jet terminal**

**RJNA is run by Aichi prefecture and is NOT an Airport of Entry. However, it is the first airport with a dedicated BJ Terminal in Japan. International arrivals/departures can be arranged. Located in the north, RJNA offers fast access from/to Nagoya (15~20 min by car). Aircraft parking is a short distance from/to the BJ terminal (70m/230ft).**

**Slot Application: No advance booking of slots is required. However, a parking spot should be reserved in advance. Parking spots for the next month can be secured from the first day of this month.**

**Operational Hours: 0700L – 2200L (2200Z – 1300Z)**

**CIQ Hours: Advanced coordination is required as CIQ is not regularly stationed here. CIQ officers come to the airport based on request. 3 days advanced notice is required.**

**Parking Restriction: 6nights/7days (extension can be granted)**

**Business Aviation Terminal: GA operations are required to use this facility. (14,940JPY per hour) CIQ is not available in the main terminal.**

**Permit application to use RJNA for international operations must be submitted 3 days prior to the operation date. A trip needs to be planned well in advance.**

### **RJSS (Sendai)**

**Slot Application: Slots can be applied for anytime, but their availability will be released at the end of each month for the next month's operations.**

**Operational Hours: 0730L – 2130L ( 2230Z – 1230Z )**

**CIQ Hours: Custom 0830L – 1700L ( 2330Z – 0800Z )**

**Immigration 1040L – 2025L ( 0140Z – 1125Z )**

**Quarantine (MON, TUE, FRI) 0830L – 1900L ( 2330Z – 1000Z )**

**(WED) 0830L – 1715L ( 2330Z – 0815Z )**

**(THU) 0830L – 2000L (2330Z – 1100Z )**

**(SAT) 0930L – 1815L ( 0030Z – 0915Z )**

**(SUN) 0930L – 2000L ( 0030Z – 1100Z )**

**Parking Restriction: None**

**Business Aviation Terminal: NOT Available**

***The announcement of the revision of handling fee related to the consumption tax hike in Japan and our new fees on extra manpower.***

**The consumption tax in Japan has been raised from 8 to 10 percent as of 01 Oct 2019. Also, we would like to announce our price changes associated with this tax increase starting this month (applicable to the flight departing on/after 1st of OCT 2019).**

**First, 10 percent will now be added to all the taxable items in your invoice.**

**Second, our third party fees will be increased due to the tax hike as well. We have been working on reducing our internal cost to make the basic handling fee remain as low as possible, and this fee will not change. Instead, we have decided to start the new charges below.**

**A: Additional manpower charges for all the airports in Japan**

**For the flights with 8 PAX or above on arrival or departure : 10,000JPY**

**For the flights with 8 PAX or above on arrival and departure : 20,000JPY**

**B: Winter additional manpower charges for RJCC between 1<sup>st</sup> Dec – 31<sup>st</sup> Mar.**

**For PAX flights on arrival or departure : 20,000JPY**

**\*this is separate from A. For the PAX flights operating to RJCC with 8 PAX or above will be charged both A and B.**

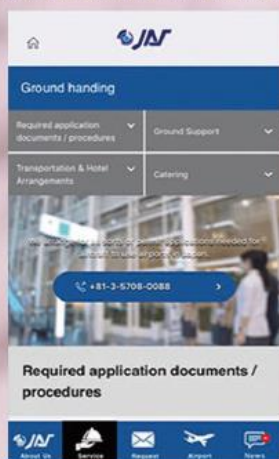
